Thursday evening sees the Conference begin with an opening lecture, to be delivered by Michael Faure (Maastricht, The Netherlands), and it concludes with a Special Session on 'Liability for Emerging Digital Technologies' on Saturday morning. The Conference provides many and varied opportunities for discussion and debate, both during the formal proceedings and the breaks and informal events.
